#### **Current Landscape for ABA Agencies in PA**

#### **New Requirement/Landscape**

The state of Pennsylvania has put in place new mandates that require providers of ABA services to provide additional staff training

- Providers (clinicians) of ABA services categorized into different levels based upon their background, qualifications and experiences.
- Different training paths with staggered effective dates (i.e. January 17, 2020; July 1, 2020; July 1, 2022)

Every individual provider of clinical services (employee or contractor) must have an individualized ongoing training plan (developed and assessed annually) that addresses the professional development of the clinician to provide the most effective ABA services to his/her consumer

Trainings required to comply with new PA rules must be provided by

- 1. State-approved Training Provider Organizations
- 2. Approved ACE CE Training Organization (BACB®)
- 3. Higher-Education Institute approved through the Department of Education
